



TAFISA Patronage Guidelines

Dear TAFISA Member,

Thank you for your interest in obtaining TAFISA patronage for your event. TAFISA is pleased to provide the guidelines for obtaining and implementing TAFISA patronage for various Sport for All and physical activity (SAPA) events being held around the world. TAFISA's goal is to support members in good standing, who are providing the platform for men and women of various age groups and abilities to develop, compete in, demonstrate and/or participate in their particular sport or physical activity in the direction of Sport for All. Events can include conferences or congresses and campaigns, as well as physical activity events.

In order for the TAFISA Board of Directors to approve an application for patronage, the following information must be presented in signed letter form addressed to the TAFISA Board of Directors no later than 6 months prior to the date of the event:

- Description of the event (type of activity, date(s), rules, venue, etc.)
- Description of participants (number of countries, demographics, e.g. age, etc.)
- Event aims/objectives, and how these are related to SAPA
- Acknowledgement and acceptance of the TAFISA Patronage Guidelines

The application process will take approximately 30 to 60 days from the time an application is received until it is approved or rejected. The application process is as follows:

1. Application for TAFISA Patronage received from TAFISA Member (no later than 6 months prior to the date of the event)
2. Review and approval or rejection by the TAFISA Office and Board of Directors
3. Letter of approval or rejection provided to the TAFISA Member
4. Assuming approval, TAFISA patronage process proceeds by following the TAFISA Patronage Guidelines
